In consideration of my child(ren) and myself participating in all of the inflatable fun located inside, I acknowledge and agree on behalf of myself and my child(ren) identified above that:

1. The risk of serious injury from participating in Bounce Town, Inc.'s activities, although minimal, does exist and includes the potential for permanent physical injury;
2. I and my child(ren) are physically fit to participate in all activities at Bounce Town, Inc. and I agree to attend to and monitor the activities of my child(ren) such that all activities are appropriate for my child(ren); and
3. I, for myself and my child(ren), knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of Bounce Town, Inc., or others, and assume full responsibility for my and my child(ren)'s participation at Bounce Town, Inc.; and
4. I and my child willingly agree to comply with the stated terms and conditions for participation and to obey the directions and requests of Bounce Town, Inc. staff. If I observe any hazards during my presence or participation, I will remove myself and my child from the participation and bring said hazard to the attention of the nearest Bounce Town, Inc. employee or official immediately; and
5. I, for myself, my child and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY WAIVE, RELEASE, AND HOLD HARMLESS Bounce Town, Inc., and its officers, agents, employees, and other participants (collectively, the "Bounce Town, Inc. Family") with respect to any and all claims for personal injury, disability, death, or loss or damage to person or property, even if arising from the negligence of the Bounce Town, Inc. Family or otherwise; and
6. This release and waiver extends to all acts of negligence by the Bounce Town, Inc. Family and is intended to be as broad and inclusive as permitted by the laws of the State of Illinois, and if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
7. I RELEASE AND AGREE TO HOLD HARMLESS AND INDEMNIFY THE BOUNCE TOWN, INC. FAMILY FROM ANY AND ALL LIABILITIES INCIDENT TO MY MINOR CHILD(REN)'S INVOLVEMENT OR PARTICIPATION IN BOUNCE TOWN INC.'S ACTIVITIES, INCLUDING SUCH LOSS, LIABILITY, DAMAGE OR COST (INCLUDING ATTORNEY FEES) EVEN IF SUCH ACTION ARISES FROM THE NEGLIGENCE OF THE BOUNCE TOWN, INC. FAMILY TO THE FULLEST EXTENT PERMITTED BY LAW.

SOCKS REQUIRED
